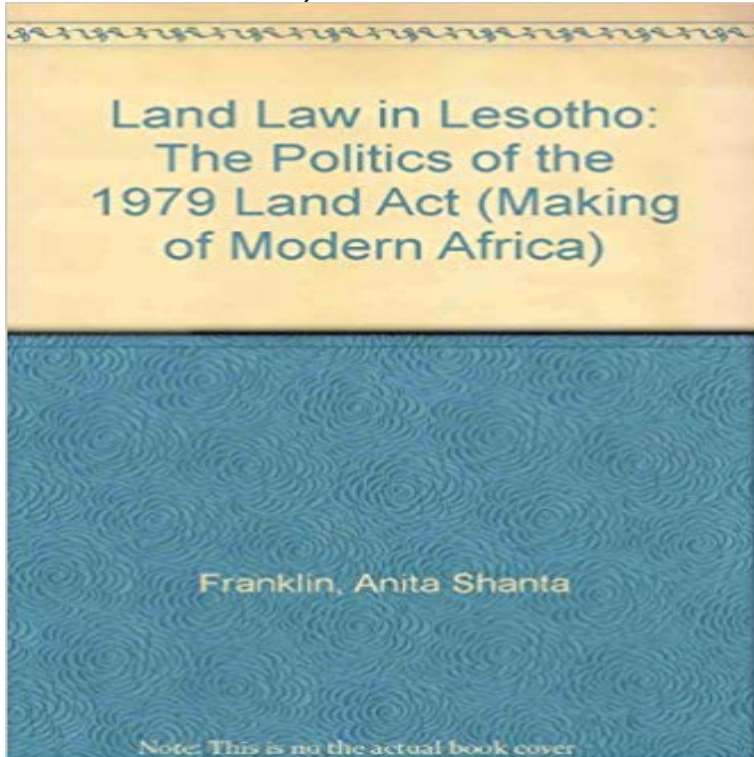


Land Law in Lesotho: The Politics of the 1979 Land Act (Making of Modern Africa)
