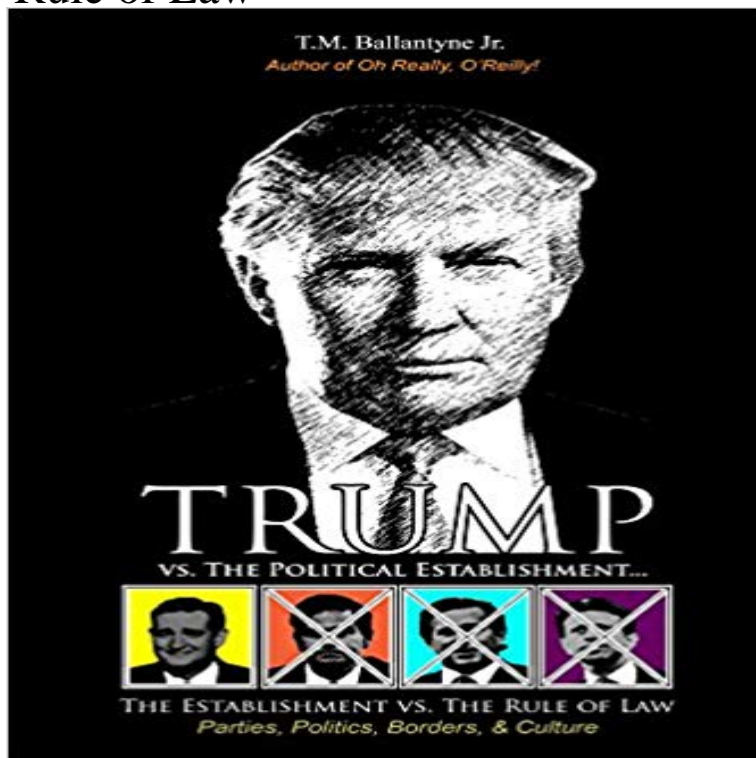


Trump vs. The Political/Media Establishment: The Establishment vs. The Rule of Law
