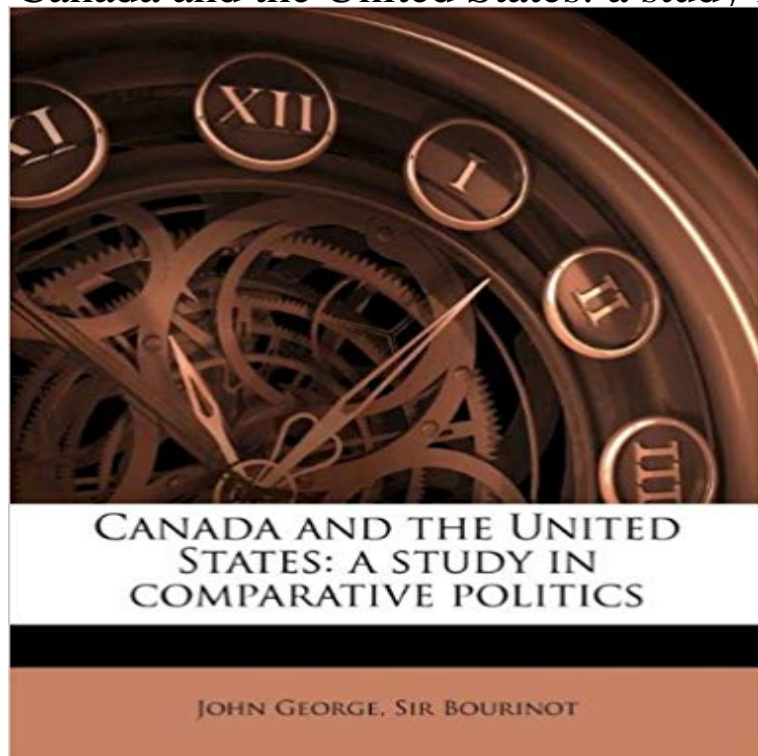


Canada and the United States: a study in comparative politics
