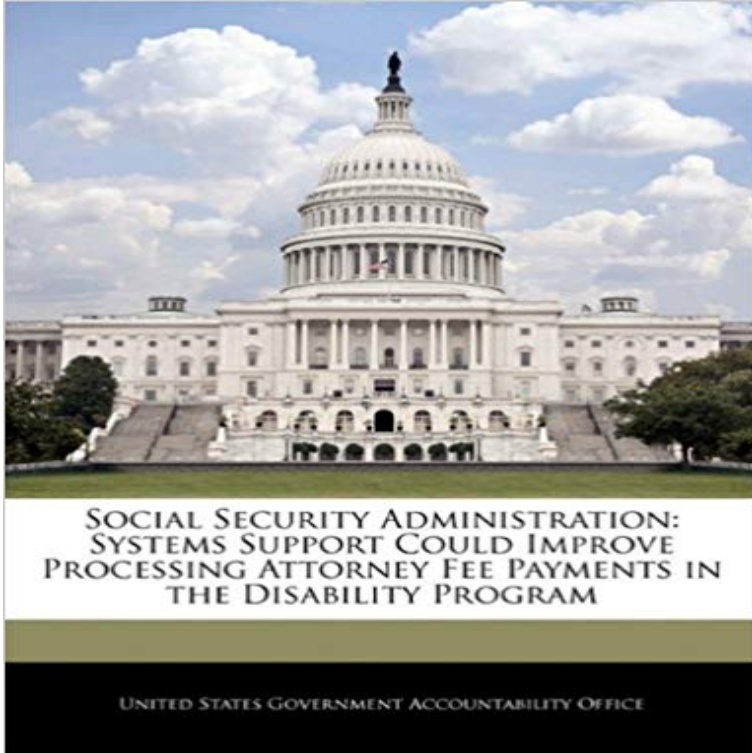


Social Security Administration: Systems Support Could Improve Processing Attorney Fee Payments in the Disability Program
